# THE NATIONAL PARENT FORUM OF SCOTLAND'S 'NATIONALS IN A NUTSHELL'

Available to download from our website, the 'Nationals in a Nutshell' summarise, subject by subject, the broad structure of each National 4 and National 5 qualification. Learners must pass Units to achieve the new qualifications; assessments for these Units may be tests or ongoing classwork. For parents and young people, this means that work during the whole of S4 is really important; for some, this work starts in S3. There are also end of year exams for many subjects at National 5. More Nutshells will appear during September and October, summarising National 1 to 3 and providing general information on Highers.

## **CURRICULUM FOR EXCELLENCE IMPLEMENTATION PLAN** 2013/14

Each year, objectives and workstreams are developed nationally for the ongoing implementation and fine-tuning of Curriculum for Excellence. This provides guidance for partners, schools and local authorities. Priorities in the Plan for this session include the publication of support materials for the revised Higher qualifications, assessment, STEM (science, technology, engineering, maths), Learning about Scotland, the 1+2 languages policy, Literacy, Numeracy and Health and Wellbeing, Gaelic; and Communicating with parents. The Plan has been circulated to many parent councils, so that they can see the wider national strategic context and understand how that links up with implementation in their school. Please ask for further information about implementation at your school and share this information with parents in your school.

## SCOTTISH QUALIFICATIONS AUTHORITY AND CHANGES **TO QUALIFICATIONS IN 2014**

As well as the introduction of the new National qualifications this session, the Scottish Qualifications Authority is making changes to the exam appeals system. The new system sets out criteria for exceptional circumstances whereby exam results may be mitigated. More information will be made available through schools in October. We have been asking that this information is more widely shared with parents and young people. Visit www.sga.org.uk for further details. # SCHOOLS CONSULTATION LEGISLATION (SCHOOL CLOSURES)

The National Parent Forum has facilitated dialogue and discussion between parents and Scottish Government officials who are working on changes to the Schools Consultation legislation which covers school closures. We have also asked that parent councils be kept informed as the legislation develops.

As well as representing us on the Scottish Government's Early Years Task Force and its Early Years Collaborative, Julie leads our Early Years Group. She has been involved on our behalf in 'The Well Connected Child' series of seminars which drew together academics, practitioners, parents and policy makers to look at the latest research on early childhood with a view to sharing knowledge and improving services. ## Getting It Right for Every Child and the Children and Young People Bill (Scotland)

Parents are beginning to find out more about the national 'Getting It Right for Every Child' (GIRFEC) initiative, as it is rolled out across Scotland. GIRFEC expects professionals in education, health and social care to work together around each child and family, whenever they need support or advice. To facilitate this, children will have a 'Named Person' who will lead the delivery of support and who will be the point of contact for children and families. If the GIRFEC initiative is enshrined in law through the Children and Young People Bill, in most circumstances, health visitors will be the 'Named Person' for children under 5 and headteachers will be the 'Named Person' for primary and secondary aged children. Following on from our submission to the consultation on the Children and Young People Bill (Scotland), the National Parent Forum has asked for parental perspectives to be represented on the GIRFEC Board.

## **LEARNING ABOUT THE 2014 INDEPENDENCE** REFERENDUM: POLITICAL LITERACY IN SCHOOLS

A new Curriculum for Excellence Briefing has been published by Education Scotland to support the learning and teaching of political literacy. This will be particularly important in the forthcoming Independence Referendum. Pupils should have the opportunity to learn about, and discuss, all perspectives fairly and without bias, as happens currently on a daily basis in our schools.

#### **COMPUTING SCIENCE IN SECONDARY SCHOOLS**

As we all know, the IT world is evolving and developing very quickly. To help with the delivery of computing science in secondary schools over the next two years, the Scottish Government is supporting a project which involves the British Computer Society and the Chartered Institute for IT in delivering professional learning to secondary teachers.
