Since its inception in 2009, it has undergone rapid development and is now an influential national and independent body, working on behalf of parents across Scotland to help every pre-school and school pupil maximise their potential.

This partnership represents a new and exciting phase of its development - an opportunity to share resources and expertise with Children in Scotland, an organisation that has similar values and vision, and whose reach spans the entire children's sector.

From May 2014, Children in Scotland will host the National parent Forum of Scotland, and the NPFS management team will share Children in Scotland's offices in Shandwick Place.

- The National Parent Forum of Scotland is comprised of one volunteer parent/carer representative from each of Scotland's 32 local authority areas. The National Parent Forum was created to provide representation for parents/carers at national level and to ensure that the parent voice is heard in education, on local and strategic issues. - Since its inception, the National Parent Forum Scotland has received the support of a host body in order to deliver its remit. The Scottish Council for Voluntary Organisations (SCVO) delivered a support function for the first six months and Learning Teaching Scotland/Education Scotland for the past three years.
